Risk Warning Notice

IMPORTANT NOTICE TO ALL PRSC MEMBERS

This risk warning is issued jointly by the Parramatta River Sailing Club Co-Operative Limited (PRSC) and the NSW Maritime Authority, pursuant to the Civil Liability Act 2002 to all persons wishing to participate in the sailing activities conducted by the PRSC.

Participants are warned that, regardless of the precautions, which might be taken by reasonable and experienced persons, sailing can be a dangerous pursuit and participants are exposed to significant risk of property damage, physical harm and possibly death.

As an indication, these risks may include, but are not limited to:

- The extremes of weather and sea conditions;
- The potential that control of vessels may be lost, resulting in collision with objects and other vessels;
- The sudden movement of the vessel at any time and the possibility that participants may fall or be thrown overboard, resulting in drowning;
- The possibility that participants may be injured by equipment on the vessel;
- The absence of immediate medical care and the likelihood that significant delays may occur before medical care is available;
- Exposure to the elements for extended periods.

The PRSC and the NSW Maritime Authority also warn participants that regardless of their best intentions, they may be unable to render assistance to participants who are in distress.

Participants are warned to consider the above risks and all other risks before deciding to participate in any sailing event with the PRSC.

Participants are also advised that although the PRSC is covered by third party liability insurance, this cover does not extend to participants. Any participant who considers they have a need for insurance must make their own private arrangements with an insurer. Australian Sailing provides Personal Injury Insurance to registered members of Australian Sailing Affiliated Clubs who, through injury or accident, incur financial loss and who otherwise have not received assistance. The PRSC also advises that boat owners intending to register for club sailing events must have a current marine insurance policy that includes adequate third-party liability insurance cover, and comply with Australian Sailing Special Regulations Part 1: For Racing Boats, in particular Section 1, 1.02 Responsibility of the Person in Charge and clauses 1.02.1, 1.02.2 and 1.02.3.
